# Rowley Elects Three Women to Selectboard

ROWLEY — The Rowley Board of Selectmen was just that a male dominated bastion that ran the town government.

But no longer. For the first time since the town's was founded in 1639, a majority of seats on the five-member board is held by women, although Deborah Eagan has been the town administrator for years.

At the May 9 town election, Sheri David was elected to replace retiring long-time Selectman Joseph Perry. She won with 38.4 percent of the votes for one of two open seats on the board.

Bob Snow, a six-term veteran of the board, who won reelection with 33.5 percent, acknowledged the historic significance of the last election. "It's good to have you," he said. "You'll have exciting times this next year.'

The majority of women elected one of the two men, Clifford Pierce, to be chairman for the fifth time. He was nominated by Selectperson Christine Kneeland and was seconded by Deana Ziev, the other woman on the

# Rte. 1 Motorists To Learn Patience

REGIONAL - If you travel Rte. 1 between Rowley and Salisbury, you are getting a totally rebuilt roadway by March

But getting there for the next two years may be a bit painful. Starting this month, traffic will be slowed while the state Department of Transportation (MassDOT) resurfaces and makes other improvements to the busy highway.

The project will repair the existing pavement that has degraded to a poor level. Bridges have also deteriorated and require routine maintenance, MassDOT stated.

The state agency promises that one lane of traffic in each direction will be kept open, and required lane shifts will have minor impact on traffic delays, but "Drivers who are traveling through the affected areas should expect delays, reduce speed and use caution," the announcement stated.

The reconstruction project, which will cost \$17.2 million of federal and state funds on an 80/20 split, begins at the bridge over Mill River, the Rowley/Newbury border. It continues slightly more than 7 miles to the northern edge of Salisbury.

It includes redesigning the well-traveled Newburyport Rotary to lower speeds, keep motorists in designated lanes and improve pedestrian and bicyclist safety.

The new Rotary will channel motorists into marked traffic lanes. Two northbound lanes entering the Rotary will remain. In a public hearing last November, MassDOT consultant Jessica Lizza said, "The inside lane would be a through or left turn lane and the outside lane would be used for a right turn only. So, the right turn lane would be for any vehicles exiting to State Street or to the business driveways on the east side of the intersection."

Route 1 south leading into the rotary will be reduced to a single lane to slow traffic, Lizza said.

All work on the project will be done between 7 a.m. and 3 p.m. Paving, milling and pavement marking will be limited to nights between 9 p.m. and 5

# Salisbury Beach 'Big Block' Is Back

complex on the beach front here is again before the town for approval.

The mixed-used project, which could be the longsought catalyst for the beach front development, would replace an aging group of bars and arcades with 235 housing units and some shops.

The new housing units, proposed by a partnership of owners of several adjacent and interconnected properties in the Salisbury Beach Town Center, may bring to the beach about 500 additional residents, who would likely stimulate new economic growth.

The town has been encouraging new investment in the once thriving beach front with a new welcoming center and a building for the popular carousel as a tourist attraction.

The 7,000 square feet of retail space will be on the street level facing Broadway and the northern end of Ocean Front South. It is designed, the proposal states, "to promote the Town's re-vitalization efforts for the Salisbury Beach Town Center" and includes stadium-style seating benches along Broadway for visitors to view the ocean and enjoy events on the esplanade.

The first row of residential use along Ocean Street South is designed as single-story units with multi-level structures located further landward and open courtyards between the single-story units and multilevel structure.

Rejected by the Conservation Commission and the state Department of Environmental Protection, the controversial project was redrawn and presented to the town for approval this spring. The ConComm will begin consideration of the revised proposal again on June 7.

#### **Letters To The Editor**

To the editor,

This year's volunteer recognition theme of Volunteers: An Essential Part of Our Team reflects both the national recognition of the impact and power of volunteerism as well as the research that surrounds the health benefits of volunteerism for the individual. According to the Stanford Center on Longevity, consistent volunteering improves the health and wellbeing of older adults. Research by the Harvard T. H. Chan School of Public Health provides evidence that volunteerism among older adults strengthens communities as well as interpersonal relationships. Data from the federal Administration for Community Living shows that approximately 10 million older adults use services funded through the Older Americans Act each year. The delivery of those services, including Home Delivered Meals, depends on the volunteer service provided by approximately half a million volunteers.

Last year, volunteers with the Georgetown Council on Aging (COA) assisted in the office, or at programs and parties, answered critical health insurance and legal questions, completed 130 income tax returns, folded 8,000 newsletters, knitted hats and headbands for Senior Center participants, called bingo games and drove 476 miles in order to provide elders with vital transportation to medical appointments. Representing a value of \$63,000 (based on a rate of \$20.85 per hour), 52 volunteers gave more than 3,000 hours of time to support the Georgetown COA, enriching the lives of older adults as well as all who live within our community.

Last week's Volunteer Appreciation Breakfast gave the Georgetown COA an opportunity to thank many of our volunteers, but we wish to extend our thanks to all of the volunteers who support our work within the community. We also thank Nunan's Plants and Greenhouses of Georgetown for their sponsorship of the Volunteer Appreciation Breakfast.

By sharing their gifts of time and self, volunteers provide the Georgetown COA with invaluable support and strengthen the community. Not only are they a resource and valuable asset to our community, they truly are the backbone of our team. We could not do the work that we do without their care, compassion and steadfast support. They have made a real and tangible difference in our lives and the lives of others. We thank them with deep appreciation.

# Beach 'Big Block' Is Back

in development since 2017, initially drew considerable opposition in town because of its proposed height and location, blocking other housing units from easy access to the beach.

The Planning Board was less concerned with the size of the \$130 million project and approved it unanimously. The new proposal calls for a 107,265-square-foot building.

The ConComm was concerned about the building's environmental impact, including the impact rising seas, powerful storms and coastal erosion would have on the building and the beach.

Commission chairwoman Sheila Albertelli said, "I have seen many times, year after year and storm after storm, the destruction that occurs down there from the velocity and the strength of these waves hitting these buildings and these dunes with the force of a freight train."

Working with Hughes Environmental Consulting in association with Epsilon Associates, the One Oceanfront partnership proposes to construct a new pilesupported building which allows the movement of sand and flood flow under the building. Putting it on piles will also make the building approve them.

It also is proposing to remove pavement on Ocean Front South, reduce impervious surfaces by 1.2 acres and enhance the dune function by removing foundations and other obstructions.

On-site parking with 354 parking spaces will be provided in a garage structure, which will have grade-level and elevated parking.

The newly redesigned complex addresses the issues raised by the ConComm and DEP by removing the below-grade horizontal structural beams, removing the paved road surface along Oceanfront South and replacing it with a smaller roadway consisting of a mixture of gravel and shell fragments to establish a pervious surface compatible with the dune environment, and restoring the remainder of this area to dune.

The utilities will be moved landward and buried. Some 30,000 cubic feet of foundations, frost walls and debris buried in the dune will be replaced with sand.

The Planning Board will leave approval of the project to Scott Vandewalle, the head of inspection services, unless he decides the changes are extensive enough to require it to



# Health & Wellness 😻

Bad breath is breath that has an unpleasant odor. It's also known as halitosis. This odor can occur from time to time, or it can be long lasting, depending on the cause.

Millions of bacteria live in the mouth, particularly on the back of the tongue. In many people, they are the primary causes of bad breath. The mouth's warm, moist conditions are ideal for the growth of these bacteria. Most bad breath is caused bly something in the mouth.

Some types of bad breath are considered to be fairly normal. They usually are not health concerns. One example is "morning mouth." This occurs because of changes in your mouth while you sleep. During the day, saliva washes away decaying food and odors. The body makes less saliva at night. Your mouth becomes dry, and dead cells stick to your tongue and to the inside of your cheeks. When bacteria use these cells for food, they produce a foul odor.

#### HOW TO AVOID STINKY BREATH

In addition, bad breath can be caused by the following:

Poor dental hygiene - Infrequent or improper brushing and flossing, allows bits of food that are stuck between the teeth to decay inside the mouth. Poor oral hygiene eventually will lead to periodontal (gum) disease, which also can cause bad breath.

Infections in the mouth - These can be caused by either a cavity in a tooth or by periodontal (gum) disease.

Respiratory tract infections - Throat, sinus or lung infections.

External source - Garlic, onions, coffee, tea, cigarette smoking, and chewing tobacco, all contribute to halitosis.

Dry mouth (xerostomia) - This can be caused by salivary gland problems, medicines or "mouth breathing." A large number of prescriptions and over the counter medicines cause dry mouth. Xerostomia is a major contributor to bad breath and advanced dental decay.

Illnesses - Diabetes, liver disease, kidney disease, lung disease, sinus disease, reflux disease and others.

Bad breath caused by dental problems can be prevented easily with proper home and professional care. Your dentist will review your medical history for conditions that can cause bad breath and for medicines that can cause dry mouth.

Your dentist may refer you to your

family physician if an illness is the most likely cause. In severe cases of gum disease, your dentist may suggest that you see a periodontist (a dentist who specializes in gum problems).

If the cause is systemic, you will need diagnostic tests to check for lung infection, diabetes, kidney disease, liver disease or Sjögren's syndrome. The type of tests you get depends on the suspected illness. You may get blood tests, urine tests, X-rays of the chest or sinuses, or other tests.

The treatment for bad breath depends on the cause. As with all medical issues, it is best to follow regular professional maintenance appointments.

One of the best things you can do daily is scrape your tongue with a....you guessed it.....tongue scraper. Brushing the tongue is not advised as this pushes bacteria further into the tongue. A tongue scraper is designed to pull and collect millions of bacteria that accumulate on the tongue. If you don't have one, ask your dentist for one at your next appointment.
