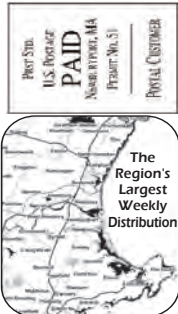

Town Releases 'Imperfect, Incomplete' Stirm Group Report

GEORGETOWN – Amid complaints from the SelectBoard chair and several members that the Stirm Group report is flawed, the board last week unveiled the long-awaited report from the private detective firm about the town's Conservation Commission (ConCom) and particularly the former Conservation Agent.

The board accepted the report by the Newburyport firm, which cost the town \$10,000, but in its official response said it "finds (the report) inadequate and does not endorse it."

SelectBoard member Laura Repplier called it a "misuse of funds." SelectBoard chair Robert Hoover said, "nothing important has come out of this report."

Member Michael Donahue said he planned to refer the report and his comments to the Essex County District Attorney (DA), claiming SelectBoard member Rachel Bancroft had committed

a crime by filing a "false police report." No other SelectBoard member agreed to join Donahue in filing with the DA.

It was not the first time the issue has been referred to law enforcement. The state Inspector General (IG) reviewed the issue of what Town Administrator Orlando Pacheco called "vast payroll fraud." The IG could not substantiate the charge.

The report is the latest battle in a long-standing power struggle among town

As a lifelong *Jaws* nut, I've celebrated in a million small ways. I've gone on all the tours, reenacted scenes when no one was watching, and yes, even gave my daughter the middle name "Ellen" after Chief Brody's wife. But this June, I'm doing something that little Gabe—the one glued to the screen in 1987 — would've lost his mind over: I'm bringing my 1975 replica Amity Police Blazer to Martha's Vineyard (aka: Amity Island) to celebrate the 50th anniversary of *Jaws* on June 20th. And not just to visit—we'll be part of the weekend festivities, including watching *Jaws* outdoors, right where it was filmed.

Let me back up a bit. About five years ago,

in the middle of lockdown, I was doing what I've done every few months since my twenties: checking online for a mid 70's

Plum Island: 2 Women Mourned

PLUM ISLAND – Many details have yet to be released regarding the deaths of two young women described as best friends, Dahiana Canas, 25 of East Boston, and Vanessa Correa, 25 of Lynn, who drowned off Plum Island Point last week.

Did they go to the beach to swim, or was that an after-thought (were they dressed for swimming)? How did they get in the water? Did they park? What vehicle? Where? Were they with other people? Did anyone see them? Do they have children? Their families?

Apparently both came from small town in Columbia, and at least one of the women may have a small child, and at least one of them may have had her organs donated by to save others.

The women were initially brought to Anna Jacques Hospital and later transferred to hospitals in Boston and Burlington in critical condition. Canas passed away on Thursday, June 12, and Correa passed away a day earlier on Wednesday, June 11.

Who were the "fishermen" who removed the women from the water, unresponsive? What were the young women doing around 7 pm on a Sunday night? Were they dressed for swimming? Was alcohol or any other substance involved? If one had a small child, what is the future for that child?

These are just a few of the many questions which we have heard in various conversations about this sad tragedy. According to a press release issued by the firm John Guilfol Public relations and echoed throughout the local and Boston media: "preliminary investigation suggests this incident to be a tragic accident. The investigation is being conducted by Newburyport Police and the Essex County District Attorney's Office." ♦

officials about the ConCom, which regulates the town's wetlands.

Some town officials, including a few developers, bankers and property owners, believe the ConCom prevents growth in town, while others see the ConCom as a last stand to prevent the abuse of green space and wetlands.

Accusations were made by SelectBoard and ConCom members that the Stirm Group, headed by a former state police officer, used "intimidation, blackmail and harassment tactics" as part of its investigation.

Laura Repplier, a SelectBoard member and former member of the ConCom, blasted the report, saying it "does not provide the information the firm was contracted to provide" and that it included information unrelated to the scope of work.

She also wrote, "Rumor, gossip and speculation should not be included in a factual investigation." No attempt was made to substantiate the validity of personal opinions in it, she wrote.

Repplier concluded that the funds paid to the group were "misused in the investigation and in writing of the report."

Newly elected Selectman Michael Donahue, who supported the Stirm Report, but agreed it was "imperfect," read a lengthy memorandum he wrote about issues he perceives with the ConCom. He claimed Bancroft had committed a crime when she filed a police report with former Georgetown Police Chief Don Cudmore that the Stirm Group used intimidation, blackmail and harassment tactics against her, Shreder and other town officials.

SelectBoard and ConCom members claimed the investigators, whom they nicknamed "Stirm Troopers," hid in bushes and the stairwells of Town Hall to accost town officials. Most of the startled town officials declined to answer the investigators' questions, which was blamed for the incomplete report.

After Donahue threatened Bancroft with criminal prosecution, Hoover offered her a chance to defend herself. Bancroft said she felt she had been "blindsided" and had "her knees knocked out from under her" and

would address Donahue's accusations at a future SelectBoard meeting.

Donahue has filed complaints against Bancroft before. Last year, before being elected to the SelectBoard, he wrote a 1,300-word petition, requesting that Bancroft be removed from the SelectBoard for being "unprofessional." The board did not act on his petition.

The private detectives were asked to substantiate the town administrator's claim of "vast payroll fraud," allegedly committed by former Conservation Agent Steve Przyjemski, Shreder and Bancroft.

The report concluded only that Przyjemski was often out of the office and was seen by unidentified town employees leaving Town Hall during the day.

Shreder, who headed the ConCom for more than 20 years, called Przyjemski a highly qualified conservation agent, who spent much of his workday, inspecting encroachments on town wetland sites.

Przyjemski resigned two and a half years ago, blaming Pacheco for creating a "toxic

Shreder, in frustration with town government, joked at a ConCom meeting that a good use of Town Hall was to set it afire so the Georgetown Fire Department could practice putting out fires.

At a SelectBoard meeting, he apologized for the comment and explained it was meant as a joke after a SelectBoard member claimed that it frightened some employees.

Smith sent Bancroft an email that she characterized as extortion, blackmail and intimidation by the group. Smith wrote: "Please understand that failure to comply with this request will compel us to act. Specifically, we will proceed to forward the video footage featuring Carl Shreder, threatening to burn down the town hall and the video recording of the special hearing conducted on August 28, 2023, to address Mr. Shreder's arson threat."

"Additionally, we will forward the handwritten letter we received from you in response to our public records request that confirms you do not have a letter from the Ethics Commission authorizing you

to participate as a select board member in any discussion or vote that pertains to the Conservation Commission.

"Our decision to send this package to the Ethics

Commission is a result of our investigators' perception of a potential bias in your actions, which seemed to prioritize the interests of the Conservation Commission over your responsibilities as a member of the select board. Additionally, your continued reluctance to engage in our assessment, which the town has contracted us to perform, has raised concerns," he wrote.

Smith concluded: "The choice is yours, Ms. Bancroft. You can opt to participate in the assessment as requested and provide the ethics-related information we are seeking, or we will proceed with the actions outlined above. We hope for your cooperation and look forward to your prompt response."

"Ms. Bancroft, if you have come to remember things differently after having time to reflect, I strongly encourage you to correct the record as soon as possible." ♦

environment."

Stirm Group president Larry Smith, a former state trooper, demanded that Bancroft turn over a copy of a letter from the State Ethics Board. Bancroft informed Smith that no letter existed because the Ethics Board attorney spoke to her on the phone.

She had inquired if there were any conflict under state law with her serving on the SelectBoard and the ConCom. Bancroft said the attorney told her that there is no conflict.

Smith appears to threaten Bancroft that if she did not provide the letter or give the Stirm Group the date and the name of the state attorney she spoke to, he would file a complaint against her colleague Shreder with the State Ethics Board for a sarcastic remark he made.

This arboretum will be a living classroom and provide an opportunity to experience "a connection between trees, the earth, and humanity".

Arboretums are more than collections of trees that provide natural beauty; they exemplify environmental stewardship, support local wildlife, ecosystems, and encourage a

reverence for the environment.

"Trees enrich the world with their presence and existence." Essex Tech's arboretum's legacy will encourage us to "protect, celebrate, and find inspiration in the world around us."

I would like to thank Matthew Martin for inviting me to the opening ceremony of the Maplewood Arboretum. I would also like to thank the residents of Massachusetts for supporting vocational education in our exceptional state. ♦

Chevy Blazer like the one Chief Brody drives in the movie. This time, in July 2020, the universe tossed me a curveball—in the form of a mint-condition model going up for auction in North Carolina. It was a '75 K5 Blazer, and already had the same paint job as Brody's.

It felt like fate. 2020 was the 45th anniversary of *Jaws*, and here was this dream vehicle calling my name. I called my wife, told her my budget, and waited with uncertainty for her response. She said something I'll never forget: "You work eight days a week, you don't have any toys, and you've been talking about this car since our third date. Go for it." That's all I needed.

After winning the auction on my final

bid, I flew to Greensboro, North Carolina, and drove that old boy—now affectionately known as Marty, short for Martin Brody—through the night, all the way back to New Hampshire. It wasn't the smoothest journey, 800 miles and some unexpected on the job training, but I was grinning the whole time.

Over the next several months, I turned Marty into a screen-accurate replica. Amity Police door decals, cherry top lights, black roll bar, white rear panel, new side mirrors to match Brody's, and even the identical hubcaps.



"AMITY" vanity plates? Of course. Replica yellow barrel from the Orca in the back? Check. And yes, The Spicy Shark branding on the back. Because if there's one thing I love as much as sharks, it's spicy food—so much that I started my own hot sauce company. It's all connected.

Which brings me to this June. I'll be back on Martha's Vineyard for the first time since Jawsfest in 2012. That was a life-changing weekend where I met people like Joe Alves, Carl Gottlieb, Alex Kintner, Mrs. Kintner, Chrissy Watkins, Deputy Hendricks, and Wendy Benchley—Peter Benchley's wife. Meeting Wendy and learning about her fight to help save sharks from extinction was part of what inspired me to get involved in shark

conservation, learn to dive, and eventually create The Spicy Shark. Without Jawsfest, there might not be a Spicy Shark. Wild, right?

This time around, I'll have Marty with me, as well as my family. I'll be cruising the same roads Spielberg filmed on over 50 years ago, but now I'm behind the wheel of Brody's truck. It feels surreal. But even better? I've been telling my daughter Joanna for years that when she finally sees Jaws for the first time, she will also be eight years old, but it's going to be right on "Amity Island." And now, she will. With her dad, surrounded by fellow Jaws people, under the stars on the very island where it all began.

That's the magic of this movie—it brings people together. It creates a community of fans who share a deep, quirky love for a film about a shark that terrorized a summer town and brought together three unlikely heroes. And in my case, it sparked a life path, a business, and more cherished memories than I can count.

So here's to 50 years of Jaws, to Marty the Chevy Blazer, to Amity Island, and to never outgrowing the things that make us feel alive.

Amity, as you know, means friendship. ♦

Beverly Police Department and Law Enforcement Partners Successfully De-Escalate Mental Health Crisis

BEVERLY – Chief John G. LeLacheur reports that the Beverly Police Department and law enforcement partners successfully de-escalated a situation involving an individual experiencing a mental health crisis.

Late last month, the Beverly Police Department was called to an apartment complex on Rantoul Street (Route 1A) for a report of a individual experiencing a mental health crisis who may be armed.

Beverly Police responded, set up a

perimeter to maintain public safety, and requested assistance from the Northeastern Massachusetts Law Enforcement Council SWAT Team, which includes specially trained negotiators. Elements of the Massachusetts State Police responded as well.

After about three hours of negotiations, the individual who was barricaded inside an apartment surrendered peacefully. There were no reported injuries.

The individual who was in crisis was

transported to a local hospital for evaluation. He is not facing criminal charges.

"I want to thank our partners at NEMLEC and the Massachusetts State Police for assisting us with this potentially dangerous call," said Chief LeLacheur. "SWAT Team members used their training and expertise to bring this call to a peaceful conclusion. The individual in question will now be connected with appropriate services that can help him in the future." ♦
