Leaving 'A Good Ministry'

NEWBURYPORT - While the First Religious Society Unitarian Universalist Church (FRSUU) on Pleasant Street is celebrating the beginning of its fourth century serving this city, it is losing its beloved minister, the Rev. Rebecca Bryan.

Rev. Rebecca, who is beginning her eighth year as the senior pastor, has decided to leave the church in June to explore what the next chapter in her life will be. She will leave after the church's annual meeting. This timeline allows the church to move forward with an interim ministry next fall.

It also gives her and the church members time to say good bye, grieve and



assess what the church needs in a min-

Asked for his and the congregation's reaction, Bob Higgins, chair of the parish board, said, "First, I cried. It was a shock to all of us. We are saddened."

Replacing her will be a challenge,

Higgins said. "She has an amazing ability to connect with everyone. It is like losing a friend.'

In a letter to the congregation, Rev. Rebecca said, "Our shared ministry has been exquisite. It is both tender and brave, forward-looking and honoring of the past. Together we have weathered many changes within and beyond our church and thrived while doing

She leaves the church larger and stronger and a greater force for community good. The supporting members and friends have doubled to about 600, "bucking the trend" in New England of declining church memberships, she said.

"It's the same beautiful building, but it is not the same church," she said in an interview last week.

The First Religious Society, which embraces pluralism and diversity, has long had many individual members who were active in the community, serving on boards and committees, fighting for justice and equality. Now, she believes the church has grown to be more committed, as an organization, to activism in the community.

The church opened rooms in the building to host the 11-member Mirzayee family from Afghanistan at



Rachel Bancroft Fires Back

member Rachel Bancroft said last week she has avoided commenting on unfounded attacks on her personally and as a public official, "but in response to the continued attacks on me, I feel the need to set the record straight."

Bancroft called the continued attacks on her by SelectBoard member Mike Donahue and resident Kevin Wood to be "half truths," woven together to create a false picture.

"While I am a public official, I understand that my life is more on display. But my private life, including the lives of my two children, one of whom is a minor, must be off limits," she said. "I will extend that courtesy even to my attackers, as much as I disagree with

In a recent social media post, Wood reported details of her on-going divorce proceedings and mentioned her children.

Donahue's four-column letter in last week's Town Common criticized Bancroft for "intimidating" anyone whom she perceives to be a threat to "her beloved" Conservation Commission. He accused Bancroft, the chair of the ConCom, of "obstructing" any investigation of ConCom "misgivings."

"I have never obstructed any investigation," she said.

Bancroft, who has been on the Con-Com for 13 years, said that she is loyal

to the town's bylaws that govern wetlands. "Wouldn't you expect that someone on the ConCom would be loyal to the town's bylaw and state wetlands laws? I make every effort to follow the bylaw and precedents. That's to the town's benefit.

Some developers, business owners and residents are unhappy with Con-Com decisions that limit encroachments on town wetlands and water supply. "Everybody is not going to be happy 100 percent of the time," she

"The commission has become a battering ram," she said. "A small group of town residents twist the facts.

Donahue also accused Bancroft repeatedly of filing police reports as a way to intimidate critics of the Con-

She acknowledged that she has brought matters to the police when they were warranted. In one, other ConCom members asked her to talk to the police about Wood, who was making them feel uncomfortable in a meeting. An attorney for the town's law firm, KP Law, asked Wood to leave the meeting so the commission could go into executive session.

The attorney called Wood's behavior bizarre.

Police open a file on any issue brought to them, she said. None of Bancroft's issues have been found by the police or any law enforcement agency to be false.

She also talked to the police in support of ConCom staff members, who said they felt intimidated in Town Hall. Both staff members have since resigned, blaming the "toxic" environment in town hall.

Bancroft said the town owes the previous conservation agent an apology for the way some town officials treated

"He was on call 24/7," dealing with ConCom issues at night and on weekends, she said. He would meet with residents as early as 5:30 a.m., but only the ConCom knew that.

Bancroft said the source of many of the accusations against him and other town officials, were brought by a disgruntled employee in 2018. They have been investigated repeatedly by state agencies and town counsel and were found to be baseless.

The SelectBoard hired the Stirm Group, a private detective firm, to investigate the ConCom. The Select-Board sharply criticized its report, which cost the town \$10,000, saying it "finds (the report) inadequate and does not endorse it.'

SelectBoard member Laura Repplier called it a "misuse of funds." SelectBoard chair Robert Hoover said, "nothing important has come out of this report.

However, Donahue, who is serving his first term as a SelectBoard member, continued to criticize Bancroft for not cooperating with the Stirm Group's investigation.

"I cooperated with the Stirm Group. I don't like their tactics. A lot of people complained about their tactics,' she said. The firm employs former law enforcement officers, but it is a private



Sand-Mined Farm to Be Sold?

GEORGETOWN - Last week, at an untelevised joint meeting with the SelectBoard, Georgetown Town Manager Orlando Pacheco told the town's Board of Assessors that the controversial 214 North Street farm is in the process of being sold.

Pacheco said the property would most likely be under agreement for sale to an unnamed developer "by December first. She's going to sell the property, the whole property.

The 100-year-old farm has 28 acres, five of which were recently being mined for its sand. The plan was to mine other 5-acre parcels for the valuable sand.

Town hall sources confirmed that the future developer has met with the planning, conservation and other offices investigating the property, reviewing maps, asking about utilities, water, and determining any offsets and any limitations on placing an untold number of homes/townhouses/apartments on the parcel.

Pacheco stated the developer was looking at adjacent property too to allow proper access to the property for a large development.

The farm's sand mining has filled pages of this newspaper and other publications this year, following its extensive, unpermitted open-pit sand mining operation in a residential neighborhood. A spokesperson for the owner said he was allowed to mine the sand as part of an organic farming operation. Mining stopped shortly after he hit the water table at 19 feet.

"Nineteen feet? I would have dug down 191 feet if I could have," to mine the sand and sell it off to concrete plants and others, contractor Todd Champlain told The Town Tommon

Contracted by the farm's current owner, Kathy Potter who inherited the land when her father Pete Zibell died, Champlain had his excavation and screening machines shut down in late August by a court order.

According to neighbors who attended the joint meeting of the SelectBoard and Assessors, the dumping and burial of construction, highway, and other debris has gone on unmonitored for vears.

Board of Assessors Chairman Thomas Berube said that "five acres of formerly productive crop land, converted to a sand and gravel quarry which is a change of use - triggered certain actions." He went on to detail the tax subsidies that the former farm owner enjoyed under Mass. Law 61A which taxed the land at a fraction of what a residential property would be taxed.

"Basically, the taxpayers in town have


Dr. John Anthony Regalbuto Last of the Greatest Generation



John Anthony Regalbuto was born, as he liked to say, on 1-2-33 (January 2, 1933) and died peacefully surrounded by family on October 8, 2025 at the age of 92. He was the youngest and last surviving of eight children of Filippo and Carmela (Pellegrino) Regalbuto, who had emigrated from Mistretta, Sicily to Little Italy in Cleveland in 1912. He was preceded in death in 2017 by his wife of 61 years, Carole Darlene Zachman Regalbuto. John and Carole were an amazing couple,


having four children in five years, and this while John was obtaining his Ph.D. in mechanical engineering at Princeton University. The four children who survive John, Mary Jean, John Robert (Monica), David Philip (Carrie Olmsted), and Michael Anthony (Deborah), are three engineers and a scientist who married three engineers and a scientist. John had eleven grandchildren and seven (and counting) great-grandchildren at his passing.

John had a lifelong passion for things mechanical, the first being aircraft. He regretted being too young to serve in World War II and admired his older siblings who did, including his sister Mary Regalbuto Jones who was a Women Airforce Service Pilot (WASP). John began his career working on Sikorsky helicopters, and after his graduate degree, worked on F16 fighter jets at General Dynamics in Ft. Worth, Texas. He eventually applied his metallurgy expertise to develop explosives for the oil industry at Jet Research Center in Arlington, Texas, and later for defense contractor Textron Systems in Wilmington, MA. While he left aircraft in his professional work, they were his dearest hobby; his production of free flying and scale model airplanes was truly prodigious. Flying sessions with his cronies in the Flying Aces Stealth Squadron #49 modeling club were the highlight of his month; he shared his love for modeling - flying sessions were keenly anticipated by the children in their youth. At the age of 85, his ingenious design of a contra-rotating propeller led to two patents and two technical publications.



John and Carole spent their retirement in Georgetown, Massachusetts. John exchanged his antique MG for a bright red Ferrari 308, perfect for the wooded, curvy roads of New England. Many dear friends made it down to John's favorite wintering spot on Grand Cayman Island. Since 2018, John lived with his children either in South Carolina (winters) or Michigan (sum-

He will be interred next to Carole in Harmony Cemetery in Georgetown, following a funeral mass at St. Mary's church (94 Andover St, Georgetown, MA 01833) at 10:30 a.m. on Friday, October 31. been subsidizing this farm," by shouldering the burden of taxes it would otherwise be subjected to, Berube said.

Berube detailed how the conversion to industrial use led to the roll-back of taxes

subjecting the farm to approximately \$12,000 in extra taxes. He detailed that the assessors have to follow the law on usage, and apply

taxes appropriately. They do not get involved in other issues.

More than one neighbor expressed shock that the farm owner could sell off more than \$1 million in sand and gravel, moving trucks on and off the property every five minutes and face only a minor tax bill.

At its Selectboard meeting last week, Pacheco told the SelecBoard they had just 30 days to decide to purchase the property, and that he would never recommend purchasing 5 acres of landlocked property. However, both his stated timeline and number of acres were not technically accurate.

"One of the things that I picked up on watching the portion of the selectmen's meeting from the 6th, when they were discussing this, is I think they were under the impression that they only had 30 days to get an appraisal and exercise this option," Berube said.

He said the town has 30 days to receive requested documentation from the landowner, followed by 120 days to make a decision to purchase. Then it has a 90-day window to execute the purchase. In all, the process could allow the town approximately six months to

purchase the property if it wants to.
Pacheco said there has been an

Pacheco said there has been an on-going, private discussion to resolve the legal issues that the Board brought against the property. He further detailed that the agreement that is before them now "would be a restoration" of the property to its prior bigdig condition.

Neighbors blasted the town for allowing the open-pit mining operation adjacent to their homes, saying "restoration has to be more than filling the pit: They've been dumping there for years."

Several neighbors said they took photos of asphalt being dumped and buried, and filed photos with the town. One resident said the property owners were using almost the entire property to support the mining operation. "It's a shame that for months, bells were going off, and the town did nothing. You had trucks backed up at 5:30 in the morning, lined up, nothing."

Another neighbor said. "These people, they burned us, they burned us badly. We look like fools. Organic farming? Come on."

"I wouldn't eat a thing that touched that soil," another neighbor of the former farm said. "We're looking at what? A future environmental cleanup? And they get off the hook with a settlement?"

Planning Board Chair Harry LaCortiglia suggested that perhaps the land could become part of the Essex County Green Belt and not be developed.

"Historically, Harry - and no disrespect to the conservation in town but the track record for maintaining conservation land is worse than the Cleveland Browns Super Bowl wins," Pacheco replied. [Note: The Cleveland Browns have never won a Super Bowl.]

"Our goal is not to make sure there is no development, but to make sure that it is properly sized," Pacheco said. •

detective agency, not law enforcement. "They do not have to answer their questions," she said.

Bancroft thanked the people of Georgetown for the outpouring of "support that the community has shown to me through these ongoing attacks and harassment."

the end of the war. Under her leadership, the church survived the pandemic, when other churches had to close, and the accidental death of an affiliate minister. Members, representing the church, march in the annual Gay Pride Parade, and the church offers free wedding services for members of the LGBTQ plus community because their rights are under attack. It also actively supports the annual Indigenous Peoples' Day celebration on the waterfront.

"We have remained faithful to our legacy of being a beacon of liberal religion in the Newburyport region for 300 years, at a time when fear and division have taken hold in our country. Our work and commitment to justice have grown along with us," she wrote.

The church's first full-time female minister, Rev. Rebecca serves as a member of Newburyport's Diversity Equity Inclusion Task Force and was the past chair of the Greater Newburyport Clergy Association, where she learned that the greater Newburyport community has a strong

respect for the clergy.

What attracted her to the church, she said, was its combination of commitment to tradition and openness while being innovative and embracing the new. She treasured the church's preservation of the

past, while still being open to change. Rev. Rebecca, a Unitarian Universalist for 50 years, graduated in 2015 from the Andover Newton Theological School where she was a member of the Jonathan Edwards Honor Society and a recipient of the Unitarian Universalist James Luther Adams Award for Excellence in the Study of Liberal Theology and the Gabriel Fackre Award for Excellence in Constructive Theology.

She was ordained as a Unitarian Universalist minister after a 25-year career advising and assisting nonprofit groups in organizational development and helping raise money through capital campaigns.

Before coming to FRSUU, Rev. Rebecca served as the interim Senior Minister for First Parish in Brookline and contract minister for the Unitarian Universalist Parish in Monson.

Higgins, the parish board chair, wrote 'Let us open our hearts to the emotions we might be feeling: sadness, confusion, hurt, perhaps fear or even anger, and of course gratitude. Rev. Rebecca, I'm sure, would counsel us to sit with those feelings, to share them and to love and be there for each other."

He appreciates that she is not leaving until mid-2026. Because the church and the community have changed in the last eight years, the search for a successor "will be different," he said. "We can't clone her, but we can take the best of what she is.

Higgins said changes will have to be made. "We need to learn and grow from this."

As for her next chapter, she has no strategic plan. She is excited to see what awaits her. With her talents and skills, Rev. Rebecca "will be in great demand," Higgins said.

Rev. Rebecca is the author of an instructive, inspirational book, Guided By Love, A Minister's Thoughts on Love, Hope and Justice, which can be found at Jabberwocky and Illume book stores or at the church.

She has also launched a podcast as a companion to the book, with "an amazing" producer Nick Place, she wrote. You can find her podcast, Guided by Love, wherever you listen to podcasts, she said.

"It has been my great honor, responsibility and joy to be your minister and to love and grow together over these years, she wrote to the congregation. "FRSUU is a remarkable church with a stand-up history and a bright future. We have done good ministry, my friends." ◆




